Stay Cool and Save Energy

Program overview

With AEP Texas' CoolSaver Program, you can save **up to \$150** toward the cost of a high-performance tune-up on your air conditioning (A/C) system or receive an incentive of **up to \$1,225** on qualifying A/C system replacements.

A/C tune-ups

An A/C tune-up may correct many common problems that prevent your system from cooling effectively and efficiently. CoolSaver A/C Tune-ups may help extend the life of your system, reduce energy costs and improve the comfort of your home. AEP Texas residential customers with A/C units that are at least one year old, are no more than 5 tons and have not received a CoolSaver A/C Tune-up in the past five years are eligible to receive an incentive of **up to \$150** per system.

A/C replacements

Residential customers are eligible to receive an incentive from a participating A/C contractor for installing qualifying high-performance A/C systems. Your contractor will perform an assessment to determine the correct A/C system size for your home. Incentives are paid based on new equipment size and efficiency. See the table below.

NOTE: If A/C system size is reduced by at least 1/2 ton, add an additional 50% to the incentive in the table above. If the A/C replacement is an early replacement of operational equipment, add \$25.

How the CoolSaver Program works

Make an appointment with a participating contractor.

- For a list of participating HVAC contractors, visit the program website at aepTEXASEFFICIENCY.COM or call 512-399-8842.

Complete your A/C tune-up or replacement.

- **A/C tune-up:** Your participating HVAC contractor will use state-of-the-art diagnostic equipment to evaluate your A/C system to analyze its operating efficiency and may recommend specific improvements.
- **A/C replacement:** Your participating HVAC contractor will evaluate your home, determine the appropriate system size, recommend replacement equipment and install new ENERGY STAR® certified A/C equipment.

Receive your discount.

- You will receive an immediate discount of **up to \$150** per tune-up or **up to \$1,225** per replacement from your participating HVAC contractor. Your contractor is responsible for submitting the necessary paperwork to AEP Texas.

All components must be accessible to qualify. If they are not accessible, the equipment is ineligible for incentives. Other program requirements and restrictions may apply. Customer is responsible for cost of refrigerant. Contractor will provide a quote for replacement refrigerant to be approved by customer prior to refilling.
